Subject: First Approval for school according to Maharashtra self finance

school (establishment & regulation.) Act 2012

With reference to above mentioned subject the education institute is noticed that, the institution has proposed for self financed schools (Establishment & regulation ) Act 2012 for academic year 2016-17 reference no.1,2,3 according to government regulation, the education institution is being given permission for academic year 2016-17 To 2018-19 on the basic of following conditions.

- 1) No changes can be made in future in the medium, place etc. demanded by the institution.
- 2) In case if the school set up in the place other than the approved place the approval will be automatically stand null and wid.
- 3) The management of the school fulfilling all the provisions of the Act 2009 is given permission for establishment of new school in the academic year 2016-17.
- 4) Only approved standards can be started in the Academic year 2016-17.
- 5) The approved school must be established by the management within 18 months. In case if the school is not established within the period of 18 months the approval will be automatically cancelled.
- 6) It will be mandatory for school to follow the Government orders issued from time to time, provisions of RTE Act 2009 and provisions of Maharashtra self-finance school (Establishment & Regulation ) Act 2012.
- 7) The management must give information using boards, hoardings in campus to people about self-finance school approval and it is mandatory at the entrance of the school.
- 8) No change can be made in the future in the place of approved school according to Maharashtra self-finance school Act 2012.
- 9) While filling information in the U-Dise, it will be necessary for the approved school on self-finance basis to have independent record/obtain number.
- 10) The concerned competent authority should ensure that all the provisions of the Act 2009 and Government Resolution dated 29/06/2013 have been fulfilled by the school.
- 11) It is mandatory for management to follow all Government rules related to school fee, tuition fee etc. All Government prescribed rules and resolutions related to fees must be followed.
- 12) The management should be financially well settled as they can run un-aided school. No financial help will be made in future as the approval is on permanently non-grant basis.



- 13) School building, campus, must be clean & secured for education and must have a good learning atmosphere.
- 14) All teachers & other staff must be appointed by following governments the rules & they must be paid according to rules related to payments of staff.
- 15) The educational institution must provide all infrasture according to government resolution of date 29/06/2016.
- 16) The educational institution must implement prescribed curriculum, syllabus by boards, all methods of evaluation & co-curricular activities & it must provide all facilities relating to that.
- 17) All record must be maintained related to student & staff by the education institution / management.
- 18) Rules & codes by the government, must be followed by institution / management.
- 19) Schools building must be as per National Building Code related to Government Resolution date 3/11/2009 & order of Honorable Supreme court.
- 20) It is the responsibility of the management to communicate about the said orders with concerned Deputy Director of education for the affiliation with boards.
